


What do medical records and health information technicians do?

Medical records and health information technicians are a rare breed. Their work is technical, but they bring a lot more to the table than tech knowledge. They're also effective communicators with strong analytical skills.

Here's what a typical day or week might look like:

- Reviewing patient records for accuracy.
- Tracking patient outcomes for quality assessment.
- Using classification software to assign clinical codes.
- Recording data for collection, storage, analysis, retrieval, and reporting,
- Maintaining confidentiality of patient records.



Where do they work?

This is one of the few jobs in which there's no direct patient care. Most hours (about 40 per week) are spent sitting in front of a computer in an office setting.

How much do they earn?

We know financial security is a driving factor as you weigh your career options, so let's talk about salary. The median wage for medical record specialists is \$47,180 or \$22.69 per hour.*

How's the job outlook?

The push for electronic health records (EHRs) by all healthcare providers will lead to an increased need for qualified HIT professionals that will grow by about 8% through 2032.*
