

Disclosure Statement

Mission Statement: CareerStep's mission statement is to make training in Allied healthcare professions accessible, efficient, and effective. CareerStep provides an online training platform for customers ("Learners") who are interested in Allied healthcare professions, to prepare for their first jobs, or to become more effective in their skills and competencies to advance in their career.

CareerStep Background and Qualifications:

- CareerStep was founded in 1992. Since that time, we have provided healthcare training to more than 150,000 learners in all 50 states.
- CareerStep offers online, asynchronous, training programs primarily in Allied healthcare professions.
 A CareerStep training program ("Program") can consist of either online coursework ("Coursework") or both Coursework and a third-party externship experience ("Externship"). No class or instruction is held on-site.
- A Program's Coursework is offered online and should be accessible 24 hours per day and 7 days per week, based on cloud availability, with a computer from the Learner's enrollment date to the date that the Learner's Program access ends ("Program Duration Period"). The Learner can complete Coursework remotely and at their own pace. If more time is needed beyond the Learner's original Program Duration Period,¹ then time extensions for Coursework are available <u>for</u> <u>purchase</u> that will extend the Learner's program access.

- Some Programs include textbooks to accompany the Coursework. If they are included in the Learner's Program as part of the original purchase price, these textbooks will be delivered to the Learner's designated address or electronically as an ebook to the Learner's designated email. Some Programs include a material kit to accompany the Coursework. If this is included in the Learner's Program, this material kit will be delivered to the Learner's designated address.
- If the Learner's Program includes a third-party Externship component, then the Learner will receive instructions on how to apply for an Externship via the Learner's designated email. An Externship is an unpaid temporary training experience in a workplace environment ("Site") by a qualified professional affiliated with the Site. The Learner must complete all necessary prequalification steps to be eligible for an Externship which include an application, Coursework completion, background check, drug test, show current immunizations, and other documentation that is Site-specific. If a Learner fails to complete all necessary prequalification steps by the Learner's Program original end date, then CareerStep has no further obligation to assist the Learner with an Externship.
- CareerStep is committed to protecting Learner data and privacy. See Privacy Policy at https://www.careerstep.com/privacy-policy/
- CareerStep has virtual instructors and customer service representatives ("Support"). Support is available to each Learner during their Program Duration Period during normal business hours. This Support includes access to CareerStep's community platform, access to CareerStep's Support personnel by email, phone, and chat to assist the Learner with their Coursework, third-party association certification exam preparation (by appointment), Externship preparation (by appointment), and career planning services (by appointment). CareerStep's Support personnel work with Learners on a first-in, first-out basis. The Learner may have to wait several days to receive assistance from CareerStep's Support personnel as they complete cases from other Learners who were first in the queue.
- CareerStep is registered as a Non-Degree Granting Postsecondary School under the Utah Postsecondary School and State Authorization Act (Title 13, Chapter 34, Utah Code). The institution is not accredited by an accrediting agency recognized by the United States Department of Education.

Certification for completing its Program. CareerStep Programs prepare Learners for the following third-party association certification exams:

- American Society of Health-System Pharmacists (ASHP)/Accreditation Council for Pharmacy Education (ACPE) - The collaborative group that certifies pharmacy education and training programs in the United States, ensuring they meet 41 stringent standards.
- Pharmacy Technician Certification Board (PTCB) -The most recognized and respected pharmacy technician certification in the United States.
 CareerStep is an approved PTCB recognized training program.

Minimum Enrollment Requirements: To be enrolled in a Program, the Learner must be at least 18 years of age and have a high school diploma, a General Education Development (GED) certificate or pass CareerStep's pre-qualification assessment. The CareerStep pre-qualification assessment cannot be used in lieu of a high school diploma or GED for any third-party association certification. The Learner must have strong skills in reading, writing, and speaking standard English.

System Requirements: CareerStep uses Canvas as its learning management system ("LMS") for the Coursework of the Program. Canvas is a third-party LMS that allows the Learner to work in the cloud.

For best performance, Canvas should be used on the current or first previous major release of the Learner's web browser. CareerStep recommends a laptop or PC as mobile devices such as iPads, Chromebooks, tablets or smartphones only work for basic study. CareerStep does not recommend mobile devices as the Learner's main or only source of study as additional third-party tools that CareerStep uses inside Canvas may not work on all mobile devices.

Method of Payment: Learners are responsible for full payment in accordance with the method of payment they select. Methods of paying CareerStep include:

- Self-payment via credit card
- Financing with installment payments due each month, serviced through Monterey Financial Services, LLC (a third-party servicing partner of CareerStep)
- Financing with installment payments due each month via Climb Inestco, LLC (a third-party financing partner of CareerStep)

Right to Rescind: The Learner has a right to rescind this Agreement and receive a full refund of any amounts paid to CareerStep, which the Learner must exercise if the Learner so chooses, in writing within three (3) business days from the date the Learner first receives access to the Program, which is the date of the email sent to the Learner containing the Learner's password and login for the LMS. The Learner must deliver a written rescission of this Agreement to CareerStep within such three (3) day period, or if the rescission is mailed, it must be postmarked on or before the last day of the three (3) day period. Prior to receiving the refund, the Learner must first return all training materials and supplies sent to the Learner.

Termination Rights and Refund Policy: In addition to the right to rescind, the Learner may also withdraw from the Program for any reason within fourteen (14) days after the date the Learner first receives access to the Program, which is the date of the email sent to the Learner containing the Learner's password and login for the LMS. CareerStep will refund the Learner's money in full, less a \$100 application fee, provided that the Learner must first return all training materials and supplies sent to the Learner.

If for any reason, the Learner withdraws after the initial fourteen (14) day review period, the Learner is not released from the Learner's obligation to pay the Program price and fees in full, and the Learner is not entitled to any refund from CareerStep.

The Learner's final payment price may include discounts. Applicable sales tax will be added to the total amount due and paid at time of enrollment.

If applicable to the Learner's Program, all other costs related to registration, textbooks, material kits, third party association's certification exam vouchers, access to an online learning management system, shipping and handling, virtual instructors, and Support are included in the final payment price that cover the Learner from their enrollment date to their original end date.

Time extensions for Coursework, a separate or new Externship, or additional services are also available for the Learner to purchase if needed by the Learner.



These items are optional to the Learner's Program original enrollment and end dates.

Program Completion Requirements: For

Coursework of the Program to be completed, a Learner must pass all assessments as specified in the Coursework instructions. Upon successful completion of the Coursework, the Learner will receive a recognition of program completion from CareerStep. This recognition is not a degree, diploma, or certification.
